Open to members certified C1HM and above

Due to the intensive nature of this clinic, there is a <u>15 person maximum</u> limit. Priority will be given to C2HM and above members, with open spots being filled by C1HM members on a first come basis. Priority will also be given to all DSR applicants before out of region applicants.

Prep Fee: \$50.00 for DSR Members \$100.00 for out of region members

Fee is non-refundable unless the clinic spot can be filled

Registration Deadline: January 25th

A late fee of \$25.00 will be added to all applications received after January 25th or are incomplete. Clinic space cannot be guaranteed if application is received after the due date or is incomplete.

Type of Prep: This prep will be an instructional preparatory session verses a mock test. The prep will go into detail about all sections of the HB rating, with review of the current HB cards, and demonstrations of the practical portions of the exams. This prep will not provide much individual feed back about the candidate's preparedness for the rating, but will cover the breadth of information so that the candidates can better understand the expectations for this rating.

If no rooms are found in Hernando, the closest big city is Southaven which is about 25 minutes north of the farm.

Directions to River Run Eventing-

From I55- Get off at the Hernando/Commerce St. Exit then turn left off of the ramp. At the second light (at Walmart), take a right onto McIngvale. At the stop sign, stay right to continue straight onto McIngvale. **This is a 2 way stop only. Traffic does not stop to the left. Be careful here. McIngvale will dead end- take a right onto Slocum Rd. You will take an immediate left onto McCracken. The road will twist and turn. You will go through a sharp left curve alongside the railroad tracks (this is where it changes to Love Rd.). After the sharp curve, you will look for the second driveway. 1188 Love Rd. It will be on your left. A long gravel road with a wooden fence.

NOTE: The interstate is closed at I55 and Coldwater. You must continue north until you get to the Hernando/Commerce Street Exit.

There are multiple ways to get to the farm from the interstate. Your GPS may also take you to highway 51. This is also a correct way to come.

I55- take the Hernando/Commerce Street exit. Go right off of the ramp. Stay on Commerce Street until you come to the town square. At the light take a left onto Hwy 51. Stay on 51 until you reach Love Rd. Turn left onto Love Rd. When you come to the railroad tracks, go across and then turn right. You will look for the 2nd driveway- 1188 Love Rd.
